Circuit Court of TUSCALOOSA County, 2014 Grand Jury Session

GRIFFIN, alias HEATH GRIFFIN, whose name is to the Grand Jury otherwise unknown, did knowingly agree with one or more persons, to-wit: DAVID ROBINSON &/or OTHER UNINDICTED COCONSPIRATORS, to knowingly and unlawfully distribute and/or possess a controlled substance, to-wit: AMPHETAMINE, CLONAZEPAM, DIAZEPAM, OXYCODONE, HYDROCODEONE, ALPRAZOLAM, ZOLPIDEM, LISDEXAMFETAMINE, HYDROMORPHONE, PHENTERMINE, &/or METHADONE, and DAVID GRIFFIN, or any coconspirator, performed an overt act to accomplish an objective of the agreement, to-wit: WRITE AND/OR DELIVER UNLAWFUL PRESCRIPTIONS FOR THE SAID CONTROLLED SUBSTANCE, in violation of Section 13A-12-204 of the Alabama Criminal Code, against the peace and dignity of the State of Alabama.

Count 2
